SECTION 2 — HAZARDS IDENTIFICATION

SECTION 4 — FIRST AID MEASURES

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfites, thiosulfates, and phosphates.

Store in a cool, dry place.

Wear protective gloves, protective clothing, and eye protection (P280). Wash thoroughly after handling (P264).
